4.0 Shipments From US and Canada

Daikin Applied Americas has selected **Ruan Transportation** to manage our transportation and supply chain network in the United States and Canada. These instructions cover inbound shipments (**FOB Origin**) to all Daikin Applied Americas facilities located in the United States, including the operations in San Luis Potosi Mexico. Daikin and Ruan will be providing the Daikin/RTMS Supplier Portal to manage all <u>non-parcel</u> transportation requests.



4.1 Daikin/RTMS Supplier Portal

Inbound Daikin Applied Americas Transportation Requests (DTR) should be entered in the Daikin/RTMS Supplier Portal. If the items you are shipping total less than 150 lbs. (no package exceeds 70 lbs or over 130" length and girth combined) proceed to ship them using UPS. **Daikin/RTMS Supplier Portal entry is NOT required on small parcel shipments.**

5.0 Shipments From Outside US

Daikin Applied Americas has selected **Mohawk Global Logistics** to manage our international transportation and supply chain network. These instructions cover inbound shipments (FOB Origin or Ex Works) to all Daikin Applied Americas facilities located in the United States. For shipments originating outside the United States and Canada, Seller must contact Mohawk Global Logistics at import@mohawkglobal.com to arrange for shipment or Logistics@daikinapplied.com for assistance.

6.0 Parcel Shipments

6.1 US and Canada Domestic Parcel Shipments

Inbound Daikin Applied Americas Transportation Requests (DTR) should be entered in the Daikin/RTMS Supplier Portal. If the items you are shipping total less than 150 lbs. (no package exceeds 70 lbs or over 130" length and girth combined) proceed to ship them using UPS. **Daikin/RTMS Supplier Portal entry is NOT required on small parcel shipments.**

6.2 Definition of Small Parcel

- Package weight not to exceed 70 lbs. Total shipment weight under 150 lbs
- Packages can be up to 165 inches in length and girth combined
- Packages can be up to 108 inches in length

6.3 Using UPS for small parcel shipments

- Shipments that meet the above-mentioned weights and dims should automatically be shipped via UPS (standard UPS ground is default).
- Shipments should be made on collect or Third Party Billed to Daikin Applied. Supplier should refer to purchase order or request UPS account number from Daikin buyer.
- Any express service levels should be approved by Daikin buyer before shipping.

7.0 Packaging

Daikin Applied receives a wide array of products from suppliers, both domestically and internationally. Please follow instructions contained in Supplier Quality Manual which will include:

- Limit of 70 pounds per carton/package
- Packaging must meet National Motor Freight Classification (NMFC) specifications
- Boxes/packages must be bar coded, according to Daikin Applied specifications
- Items should be properly labeled with the part number, description, quantity and weight
- Recyclable packaging materials no foam peanuts or other non-recyclable materials
- Plastic banding preferred over metal banding for safety purposes
- Standard pallet sizes no pallet over 40" x 48" unless required to properly palletize large items
- Gross weight should not exceed 1,000 pounds per pallet
- International shipments all wood packaging must meet International Plant Protection Convention (IPPC) standards

8.0 Purchased Material Label Specification

All purchase materials will be required to labeled in accordinance with Daikin's Supplier Quality Manual.

9.0 Drop Shipments

9.1 Finished Goods

Daikin may direct suppliers to drop ship purchase orders of finished goods directly to their customer. Packing list and bill of lading should reference the following:

- Daikin Purchase Order
- Daikin Sales Order
- Job Name if referenced

9.2 Replacement Parts

Daikin may direct suppliers to drop ship critical replacement parts directly to their customer. Shipment should reference the following:

- Daikin Purchase Order
- Daikin Sales Order

Any express service should be approved by Daikin buyer before shipping.
